Using 16-17 year-old driver crash data from 2001-2003, the following items were identified as being the major Possible Contributing Circumstances (PCCs). The percentage of crashes for which they were reported is also provided. Parents are encouraged to reinforce practice procedures and techniques that will help to reduce crashes from occurring as a result of any of the following PCCs. > Driver condition - 1.8%

> Inattentive driving - 18.2%

> Failure to yield right-of-way - 16.3%

> Failure to control vehicle - 15.8%

> Speed too fast for conditions - 14.0%

> Following too close - 6.8%

> Exceeding speed limit - 3.5%

> Disregarding traffic control - 2.9%

> Improper turn - 1.9%

> Unsafe backing - 1.7%

> Left of center – 1.4%

> Improper overtake - 1.0%

<sup>\*</sup> Examples: vielding right-of-way/courtesy; maintaining driving focus/attention; vehicle control/handling; speed awareness/control; safe braking; space management - front following distance (maintaining a minimum 3-4 second following distance under ideal conditions); space to the sides and rear; identification and compliance with traffic controls (including RR Crossings); proper turns and turning procedures; safe and proper backing (straight-line and maneuvering in reverse); selecting and maintaining lane position; safe and proper passing procedures and techniques; controlling emotions; proper/appropriate visual perceptive skills; and pre-driving habits (including safety belts).
